The Police Department had \$120 incident reports, \$3980 in Impound fees minus \$1900 in towing fees which equaled to \$2200. Chairman recognized & thanked Barabara Stegmeier for making a donation to the Police Dept. in honor of her husband Bob Stegmeier. The donation paid for Guardian Angels lights for the Police Officers. The Police Dept. also purchase hats with some of the donation. Chief Bonner personally thanked Barbara for her kindness and generosity. Chairman called for a motion to approve the bid for salvage. Chief said we asked for bids from 3 companies and only one responded. Chairman called for a motion to accept Zaprazny's bid for \$5248. Glenn Hummel made the motion. Tim

The Fire Department also gave a breakdown of their calls for the whole year. 2021 the Department had a total of 322 calls. 14 structure fires, 19 brush fires, 52 motor vehicles, 116 wires/trees down, 25 automatic alarms, 8 landing zones, 17 fire police calls, 29 medical assists, 14 pump details, 10 vehicle fires, 6 carbon monoxide emergencies, 1 chimney fire, 3 utility investigations, 2 transformer fires, 2 off road rescues, 3 stand bys and 1 unknown type of fire. Chairman called for a motion to accept the Fire Department's Monthly Report. Glenn Hummel made the motion. Tim Houser seconded the motion. All in favor. Motion was carried. 3-0

G. Ambulance Monthly Report

Chairman read the Ambulance Report. Chairman said they had 22 calls for the month of December and 350 for the 2021 year. The Ambulance had 3 calls in Tamaqua, 1 Rush Township, 2 East Brunswick, 1 Tuscarora, 1 Coaldale and 14 West Penn.
