I. General

A. Tony Prudenti, Chairman, opened the meeting with the Pledge of Allegiance and Introductions at 10:02AM.

IV. Old Business

A. Vacating a Portion of Rabbit Run Rd. – Attorney Datte stated that we discussed this at our last meeting and we will need to adopt an Ordinance. Attorney Datte provided a draft of the Ordinance. A. Chairman said as part of Penn DOT's requirements to receive a Special Event Permit, notification letters and certificate of insurance for the event needed to be sent out.
